housekeeping amendments identifying the utilities and transportation commission instead of the public service commission and the department of revenue instead of the tax commission.

Partial veto strikes amendment of exemption section which included publicly owned fire-fighting and certain special mobile equipment like ditch diggers, well borers, etc.

SENATE BILL NO. 108 (Chapter 95, Laws of 1969) Senators Atwood, Cooney and Mardesich

Relates to court reporters' compensation in certain counties. Increases court reporters' salaries: (1) in judicial districts having population of 100,000 or more (excluding AA counties) and in Thurston County from \$9,500 to \$11,000; (2) in judicial districts of population from 40,000 to 100,000, from \$9,000 to \$10,500; (3) in judicial districts of population from 25,000 to 40,000, from \$6,000 to \$6,600.

ENGROSSED SENATE BILL NO. 109 Senators Uhlman, Atwood (Chapter 122, Laws of 1969) and Greive

Relates to professional service corporations. Provides for the incorporation of individuals licensed to render professional services to the public; existing professional corporations may bring themselves within the provisions of this act by amending their articles of incorporation to conform; the corporation may only render professional services through employees who are duly licensed to render such services; nature of professional relationship and liabilities are unchanged by this act; no other business shall be engaged in by the corporation beside the one of rendering the professional services for which it was incorporated; prohibits issuance of capital stock to others than those licensed to render the same professional services; prohibits voting trust agreements; shares can only be sold or transferred to eligible people; registered architects may incorporate with engineers.

SENATE BILL NO. 109

- 1. Authorizing professional service corporations.
- 2. Authorizes the establishment of professional corporations for any professional services (defined as all services requiring a license or other legal authorization and which cannot otherwise be performed by a corporation). Only individuals duly licensed in the profession may be an officer, shareholder, or employee (except for employees performing nonprofessional services). The act specifically retains individual liability for malpractice or other misconduct.

Re: H.B. 109, Professional Corporations

Dear Mr. Clarke:

I have written several letters to Senators and my own Representatives regarding this and other legislation affecting the medical profession. I understand that S.B. 109 on professional corporations may soon be passed in the Senate. I want to give my reasons to you and your Committee for supporting this bill and hope you will be able to give impetus to its passage in the House.

I am a member of a professional group which has been incorporated under the laws of this state for some time. My prime reason for asking your support is selfish, but I believe this is a proper type of selfishness. There are now thirty-four states having this special legislation and the Internal Revenue Service has lost all of its suits to collect additional taxes from professional corporations in those states. Now they are applying increasing pressure against such corporations in states without such legislation and, in fact, are making their own laws when they decide that a legal corporation is not a corporation. Several years ago they told us that we met all the requirements for being a corporation. In the last year they have reversed this opinion and are now trying to collect extra taxes from us.

We believe we could win a suit but it would mean a needless waste of time and money. It seems to us that we are being treated unfairly or as if we were a special type of "fair game." We believe such legislation should not be needed and is a waste of a lot of time for you and for us, but apparently it is necessary.

In further support of my opinion, I list the following points even though you are probably already aware of them:

- 1. The American Medical Association several years ago has said that it is not unethical for physicians to practice as a corporate group.
- 2. Our profit-sharing plan is almost exactly like the Keogh plan. Under our plan we can donate at most for ourselves and our employees only \$500.00 more per year than under the Keogh plan. It would cost us a great deal to change over to the

Keogh plan: partial loss of fees already paid on a mutual fund and the expense of purchasing a new fund.

3. This legislation would help to keep money in the State of Washington. It also will help professionals to keep their fees at reasonable levels since the need to keep up with inflation of retirement will be reduced.

I have heard that there has been some criticism of this bill as a "special interest" bill. It is, of course, to a degree and certainly all legislation cannot be only for the general good. It seems to me that the special interest here only protects a minority group from attack.

I and other members of our group shall appreciate whatever support you can give H.S. 109.
