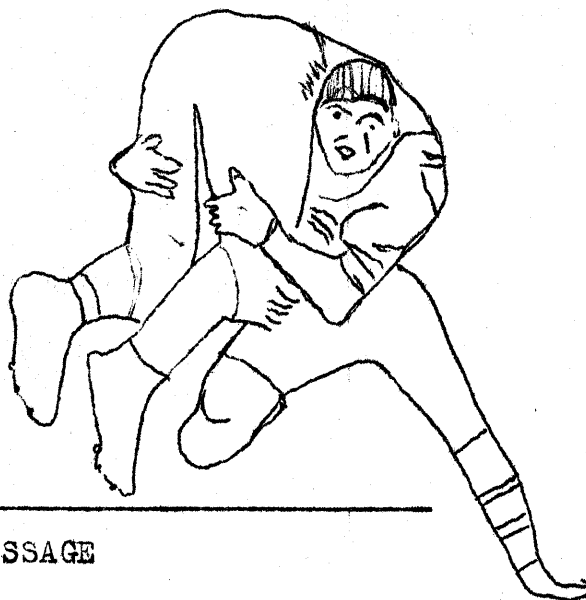

PHYSICAL FORCE IN TREATMENT

The story of the gradual evolution of treatment by physical methods makes a facinating and instructive reading. In many instances the genius of one keen observer---not necessarily a physician--recognized the healing effects of such procedures as water treatment, electricity in some form, sunlight or certain exercises, In enthusiastic heads, at first, a new method often "runs wild" and its healing virtues are magnified while its failures are disregarded. The medical profession, being conservative as a whole, wants proof of success obtained under its scrutinizing observation. For this reason only those methods are adopted that stand extensive trial in critical hands. Each and every one of the recognized physical methods of treatment had to go through a period of expert observation.

PHYSICL THERAPY AS A PART OF PRACTICE OF MEDICINE

Physical Therapy is not a new system for recognizing and treating diseases, as some of its ardent advocates, especially those who have had no medical training would make it appear. It is simply a method of treating disease and injury with the aid of physical agents, as a rule in conjunction with medical & suggical measures. After it has been definitely established what ails the patient.

In the employment of Physical treatment methods in order to derive the best results from any form of aparatus or from bathing

or exercising more is needed than the mere knowledge of how to turn on a switch or go through certain movements. The first requirement is correct diagnosis, implying a definite conception of existing pathological and functional changes. The second requirement is that if a physical measure is to be used there should be no doubt as to what that physical treatment is expected to accomplish, and third there must be a full knowledge of just how that treatment is applied. Physical treatment must be as carefully prescribed and applied as any medical treatment. It is understood that any physical treatment that is powerful enough to do good, is just as likely to do harm if incorrectly given. Physical Therapy rightfully forms part of the practice of medicine and surgery and is of most value in the treatment of disease and injury when employed by a trained technician, in cooperation with the diagnostic physician for safe and effective application.

I am inclosing a copy of a letter from the Federal Communications Commission in connection with the non-conforming diathermy machines. I believe that for the protection of our members this should be published.

Gentlemen;

This is in reference to your letter of September 28th 1953 concerning doctors using non-conforming diathermy machines.

You may advise inquirers that the Commission will enforce its Rules and Regulations to the full extent that its personnel and facilities permit, and that the Commission's district offices, including Washington D.C. and New York City, are investigation all reports of violation which come to their attention. Failure to comply with the Rules and Regulations may result in the severe penalties provided in the Communications Act of 1934, as amended.

Dear sir,

When we received a reply to this letter and if there is any change indicated on our action as taken on your bill covering services rendered on bills involved we will notify you. As the reference stands we cannot pay any amount in excess of our fees which are \$4.00 to registered Physical Therapists and \$3.00 to non-registered Physical Therapists. We also wish to point out any case that is accepted for treatment with knowledge that it is industrial, charge can not be made to the patient for any service for which he is entitled. We trust you will be agreeable to accepting payment we are permitted to allow on the foregoing basis. Please advise if you are registered with the Washington Chapter of American Registry of Physical Therapists.

I am a new member to the American Association of Masseurs & Massuses. It gives me a feeling of pride that we have such an organization, with which we may better our profession and ourselves.

I am not new, however, in the profession in which we are all interested, having been practicing Physical Therapy for the past fifteen years. Ten years of that time in North Hollywood California, when I was employed in some of the best Health Systems, and Physical Therapy Clinics, working in Co-operation with both medical and non-medical practitioners.

Because of this background and experience, I would like to offer a few suggestions, and make some constructive criticisms, for our own association, that I have observed, and heard discussed in the field of healing arts, by other practitioners in regard to ourselves.

If we hope to gain recognition in a legal and ethical way, we must be more careful of our terminology, our ethics, and our advertising. We must not speak of ourselves as Massage Operators. The word operator, should only be applied in the trades, (as a crane, truck, or shovel operator) Ours is a Profession, and we are practitioners or technicians, and should always be referred to as such. Then too, ours is not a business, but a profession, and should not be spoken of as, in the business of Massage, but in the Massage Profession, or Physical Therapy profession, as the case may be.

It has been my misfortune, as well as my pleasure to visit a great many massage and physical therapy practitioners, through out the western states. I have visited some pretty makeshift affairs, that were dirty, and the technicians or practitioners in charge were very untidy as well. Such a place certainly would not get co-operation from any ethical practitioners. It has also been my misfortune to find that in some of the Cities, the title, Massage, Steam Bath or Physical Therapy, are used as a front, for illegal practices, such as prostitution and sexual perversions. These things should be carefullu inspected and eliminated, at once, if we hope to gain co-operation from ethical practitioners and the public in general.

Now a word about personal appearances, we should strive for cleanliness in our offices and ourselves. A daily shave & Shower should be a must with the men. A shower and a neat hair do, and a clean white uniform for the women. Make up should be applied with care, because it is almost impossible to give a good thorough massage treatment without perspiring to some extent, due to the warmth of the room for the comfort of the patient, and the active exercise on the part of the practitioner. Men should wear white trousers, and either a well fitting white tee shirt, or preferably the white coat, buttoning at the neck, cut over the shoulder and down the side. Do not work in soiled or untidy clothing. Wear good fitting shoes, preferably the sponge rubber soles. They are easy on you, and you can glide noiselessly about your work. Don't chew tobacco or gum while giving treatment. Don't high pressure your patient into purchasing vitamins, or other remedies while giving treatments, wait until you have finished if you must do it, your patient will relax and cooperate much better. Don't brag about what you have done or can do. Don't criticise your fellow practitioner or those of other healing arts to your patients. Be impersonal as well as professional in your manner, when treating either sex, and you will have much better cooperation from both.

It has been my pleasure to visit, and be employed in the finest most modern, and scientifically equipped Physical Therapy departments available. Now that I am in private practice, for myself, it is my aim to conduct my office, and myself in the most professional manner, as taught me through contact and observation of professional men and women in professional practice.

Trusting that this thought may be of value to some of my fellow practitioners.
